LENDING OF A NEW PATENTED HIGH SECURITY ANTI-SPLASH SYSTEM FOR DEMONSTRATION AND EVALUATION

This agreement is issued in response to a request made by you and/or your organization (*Name, Address, Phone number, Contact -*
Print Here)

to allow the Company "On The Gate, LLC" (hereby addressed in this agreement as OTG) to temporarily supply (1) fully functional Patented Anti-Splash System Evaluation Unit (hereby addressed in this agreement as PASS) to the Client for a 30 day evaluation period, strictly for the purposed of evaluation and non-destructive, non-damaging non-dismantling testing of the PASS unit by the Client.

The PASS units will be supplied to the Client in "NEW" condition and must remain in that condition while in Client's possession.

The Client must return the PASS unit to OTG (within a 30-day period starting from the day this agreement is executed), in the same "NEW" condition as it was supplied to the Client by OTG.

A Deposit will be supplied by the Client to OTG in the amount of \$3,995.00 (Three Thousand, Nine Hundred and Ninety-Five Dollars) in the form of a charge card, or other acceptable means as to be determined by OTG.

When the PASS unit is returned to OTG within the 30-day evaluation period, in the same "NEW" condition as supplied to the Client, the \$3,995.00 (Three Thousand, Nine Hundred and Ninety-Five Dollars) deposit will be returned/refunded to the Client, less shipping charges (not to exceed \$378.00 dollars) that were incurred by OTG for the shipping of the PASS unit.

If the Client decides to keep the PASS unit, the Client will be charged a total of \$3,995.00 (Three Thousand, Nine Hundred and Ninety-Five Dollars), plus a shipping charge of \$189.00 (One Hundred and Eighty-Nine Dollars), for a total charge of \$4,184.00 (Four Thousand, One Hundred and Eighty-Four Dollars). This charge does not include Sales Tax.

If the Client is a "SALES TAX-EXEMPT" entity, Client must submit to OTG a completed "W9" Tax Form. If Client is not a "SALES TAX-EXEMPT" entity, appropriate Sales Tax charges will be added to the final costs of the PASS unit in accordance with Client's State Sales Tax laws.

If the Client fails to return the PASS unit to OTG within the 30-day evaluation period, or if the Client returns the PASS unit to OTG in other than an "New" condition, the Client will forfeit the deposit of \$3,995.00 (Three Thousand, Nine Hundred and Ninety-Five Dollars), and a shipping charge of \$189.00 (One Hundred and Eighty-Nine Dollars), for a total cost to the Client of \$4,184.00 (Four Thousand, One Hundred and Eighty-Four Dollars). The Client will then become the owner of the PASS unit, and all United States Patent limitations will apply to the Client's ownership of the PASS unit.

This Agreement is to be considered complete and in its entirety, and may not be amended without the prior written consent of both the Client and OTG.
